Final payment is due October 9, 2018, except for bookings made within that period when full payment is required. *All cancellations are subject to a \$200 per person A.C.T. administrative fee.* Cancellations made after October 9, 2018: \$950 per person penalty plus any additional fees levied by airlines, cruise companies (see terms of Oceania at oceaniacruises.com), and tour operators (including A.C.T.) in accordance with their regulations, penalties, and out of pocket expenses. **Cancellations made 30 days or less before departure: No refund (100% penalty).**

AIR TICKETS: Are not included in the price but will be offered when available.
